## 1. Services Provided:

The Traveling Hounds LLC ("Trainer") agrees to provide day school training services to the Client as follows:

- Structured day training tailored to the dog's behavioral and obedience goals.
- Training hours and duration will be customized to each dog's needs and program.
- Dogs return home at the end of each training day.

## 2. Fees and Payment Terms:

- Deposit: A \$250 deposit is required to reserve your dog's training spot. This deposit is nonrefundable.
- Balance: Full payment is due at or before the first day of training.
- Late Pickup Fee: \$50 per day if a dog is left beyond agreed pickup time.
- Cancellations: Cancelling your reservation means forfeiture of the \$250 reservation fee.

## 3. Vaccination and Health Requirements:

Clients must provide current vaccination records (Rabies, DHPP, and Bordetella). Dogs must be in good health and free from contagious diseases. The Trainer reserves the right to deny entry if these conditions are not met.

## 4. Veterinary Services:

In case of illness or injury, The Traveling Hounds LLC will attempt to contact the Client. If unreachable, veterinary care will be sought at the nearest veterinary clinic.

## 5. Emergency Contact Authorization:

Client grants The Traveling Hounds LLC authority to act on their behalf for emergency veterinary services if the Client is unreachable.

## 6. Health & Behavior Declaration:

Client affirms that their dog is not aggressive toward humans or other animals, unless previously disclosed, and has no known medical conditions.

### 7. Use of Training Tools and Methods:

Owners may be advised on appropriate training tools including leashes, slip leads, prong collars, e-collars, muzzles, etc. Slip leads are not used. All tool use is subject to owner approval. If a tool is deemed necessary for safety and the owner refuses its use, this will result in immediate termination of services. Tools are used responsibly and may be phased out once the dog earns trust and reliability (90%+).

### 8. Owner's Commitment:

Client agrees to participate in training handovers and reinforce techniques at home. Owners are responsible for continuing training and structure on weekends and non-training days. Lack of consistency in this area will hinder the dog's progress and results.

### 9. Media Release:

Client grants permission to The Traveling Hounds LLC to use photos, videos, or audio of their dog during training for advertising and education purposes.

### 10. Travel Authorization:

Client grants permission for the Trainer to take the dog offsite (e.g., stores, parks) for training purposes.

### 11. Damage to Belongings:

Trainer is not responsible for damage to toys, leashes, or other personal items left with the dog.

### 12. Liability Waiver:

Client agrees to hold The Traveling Hounds LLC harmless for any injuries, illness, or accidents occurring after the dog is returned. Trainer is insured but liability ends once the dog leaves the program.
